APPROVAL OF MINUTES OF PREVIOUS MEETING

A motion was made by Trustee Doug Scott to approve the minutes of the previous meeting as presented and seconded by Trustee Kenny Joseph. Motion Carried.

SUPERVISOR'S REPORT

Supervisor Ahle said a correspondence was received from the St. Clair County Intergovernmental Grants Department regarding the 2014 Program Year. Ahle reminded the board he is trying to get a grant to have a sanitary sewer system installed for the south side of East State Street which would include the Township and the Road District. Pat Judge from Gonzalez is working on the paperwork involved to get the process started. Ahle and Highway Commissioner Mark Downs are scheduled to meet with Judge on January 28th.

Information from County Clerk Thomas Holbrook regarding the General Primary Election on March 18, 2014 was received. Supplies can be picked up by the Township and Road District on March $12^{\rm th}$ at 9:30 A.M.

Precinct 18 is being moved from the Baptist Church because of construction and will be relocated to Faith Lutheran Church along with Precinct 6.

APPROVAL OF HIGHWAY COMMISSIONER'S BILLS

Permanent Road Fund \$ 6,612.84 Road & Bridge Fund \$ 18,723.31

Trustee Gary Hursey asked about a reimbursement to the road district employees for cell phones. Downs said the crew all has cell phones and if they agreed to make themselves available on the cell phones, he would reimburse them \$25 a month on their cell phone usage. This was started back in July 2013.

TOWN CLERK REPORT

Clerk David Witter reported on the township website with 424 visits. 75.7% were new visitors and 24.3% were returning visitors. 137 from O'Fallon, 44 from Affton, 32 from Belleville, 31 from Collinsville, 21 from Edwardsville, 15 from St. Louis, 14 from Chicago, 7 from Fairview Heights, 5 Minneapolis and 5 from Kansas City. Visits outside the U.S. included; Czech Republic, Japan and Ukraine.

TRUSTEES REPORT

Trustee Jeff Bevirt commented on the Community Food Co-Op that meets every other Tuesday at the Township. They have produce delivered and divided up between people who purchase the



bundles online. People are asked to donate \$1 to go towards to the Food Pantry. This along with purchases not picked up, are all given to the O'Fallon Food Pantry. Bevirt said it is a very well organized system and also a good community service for the Township to contribute use of the space. A brief discussion followed.

Trustee Doug Scott inquired about a registration form in the January issue of Perspective magazine regarding the 2014 Annual Meeting at the Regency Conference Center on August 16 for District 2. Scott wanted to know if this would be something he would want to attend. A discussion followed as to all the different workshops and speakers they provide at these meetings.

UNFINISHED BUSINESS

Supervisor Ahle reminded the board of a previous discussion to clean up the men's restroom in the hall and lobby areas. He received a proposal submitted by Kruep Construction with 3 different amounts for the partitions:

Repaint and sand the existing 2 partitions (1 in each of men's baths) paint to match existing color as close as possible - \$848.00

Replace the 2 partitions (1 in each of men's baths). Owner to choose paint color from the samples provided. Existing toilet paper holders to be reused - \$1,900.00

Install a 6' partition with door in men's bathroom and paint the partition in the other men's bathroom - \$1,472.00

Trustee Doug Scott said he would prefer to have stainless steel partitions. Trustee Kenny Joseph expressed concern whether sanding and repainting will work on the partition in the men's



bathroom in the hall. Supervisor Ahle said he did this same thing 6 or 7 years ago. A discussion followed about holding off until they can look at other material options like; stainless steel, ceramic or vinyl. Ahle said he will request proposals for different material options. He added that Kruep will check out the roof on the rotary van garage when the weather improves.
