PRESENTATION OF THE 2020-2021 O'FALLON TOWNSHIP TOWN FUND AND GENERAL ASSISTANCE FUND BUDGET AND APPROPRIATION ORDINANCE NO. 20-02

Supervisor Gary Ahle said a draft of the budget was sent out earlier for the trustees to review. He noted an increase on Capital Improvements. Ahle explained the restrooms need to be upgraded this year. Trustee Hursey asked about Handicap Accessibility with the improvements. Ahle responded; his understanding is if a new toilet goes in, it has to be handicap accessible but, for sinks or urinals, it doesn't. Deputy Clerk Allsup added we do have a restroom specifically for handicap access.

Ahle said he noticed some damp spots in the Rotary/Rummage garage where there may be some leaks on the east side. He is having Kruep Construction come out with the extension ladder to look at it. Landscaping on the east and north sides of the office building are in need of some landscaping. He added there is no point in doing the landscaping until they find out what is going on with sanitary sewer line project from the City. Trustee Hursey asked if that is coming up anytime soon. Highway Commissioner Downs said he heard the cost came in much higher than the City expected and they are trying to get a continuance on the grant from the County.

Trustee Hursey asked about the insurance through Allied for General Assistance; whether or not it has increased. Deputy Clerk Allsup said the bill came in at the same.
