Highway Commissioner Downs reported this year's overlay is complete except for a few issues that need to be addressed. The payment to Rooter is half of the total bill until all issues have been addressed.

Trustee Doug Scott expressed concern about the curve on Hagemann Rd. He said the grade for the curve leans out instead of into the curve. It should be banked, like a race track. Scott said he almost had an accident on that curve. Downs said he cannot redesign the road but, he can put a double center line on the curve. A brief discussion followed.

##### PLANNING REPORT

Update regarding the special use permit for a Planned Building Development on property known as 1805 Bowler Road containing 15.87 acres more or less. Trustee Gary Hursey reported the Planning Committee met

on August 18<sup>th</sup> and approved the request. The County met on Sept. 1<sup>st</sup> and turned it down. The board was opposed to the three 25 ft. strips of frontage he was asking for. They thought it would be precedent setting to grant that small of frontage. Hursey said this item did not come up at our meeting and doesn't know if they will reapply and it will come up again in the future. A discussion followed.

Effective August 20<sup>th</sup>, 2020 – John Hollerbach resigned from the O'Fallon Township Planning Committee. Suggestions for nominees are welcomed.

Yesterday, St. Clair County Clerk, Tom Hollbrook came to the office to check out the hall layout for early voting at the Township beginning on Monday, October 19<sup>th</sup>. Arrangements will be in place for persons not wearing a mask. Temperatures will be taken upon entering and masks will be provided.

Deputy Clerk Debbie Allsup looked into the number of signatures required for the April 2021 election. She found out that several candidates for the November 2020 election took the issue to the Supreme Court and, because of the Pandemic, got the number of signatures reduced to 10% of the original number required. Nothing has been determined yet for the Township elections in April 2021. Trustee Doug Scott has made some calls to IL State Senator Jason Plummer and IL Representative Mike Bost regarding this matter and has not heard back from either one, yet. A brief discussion followed.

Mayor Herb Roach came to the office and dropped off a case of face masks and, to let us know that masks are available to the public at City Hall and the Public Safety Building.

Trustee Frank Morski informed the board the Thanksgiving meals, usually served at the Lutheran Church will go on this year with the exception of "Take Out" meals only. A brief discussion followed.
