SECOND ORGANIZATIONAL MEETING OF THE DECENNIAL COMMITTEE

Township Report for Compliance with Decennial Committees on Local Government Efficiency Act – Review Draft Report – All agreed the draft report is very concise and thorough. Committeeperson, Andrea Fohne asked: under section VIII; Review of laws, township policies, township rules and procedures, township training materials and other documents; are all the items checked off easily accessible if somebody were to request proof. Deputy Clerk, Debbie Allsup said they are. Also, under section VIII; Designation of Whistleblower Auditing Official: Allsup stated she has not looked over the statute but, she believes that at every monthly meeting, there is time slotted for public input as well as, the minutes being posted on the township website. Allsup assumes all board members have completed and filed their Open Meetings Act Training.

Trustee Frank Morski asked about the bill for Gonzalez Companies for water testing. Downs explained; since we are an MS-4 location, we are required by IEPA (IL Environmental Protection Agency) to test the waters quarterly for any contaminants. Gonzalez does the testing for us. There are 2 (two) locations on Ogles Creek. These costs are shared with the City of O'Fallon and Fairview Heights.

Morski said he is not sure if we have any say over this one because, the neighbor is buying most of the ground and they are wanting to divide it up. Statute 109 Platte Access states the neighbor can purchase the land without having to do anything. Morski said he will wait and see what happens at the meeting.

7:30 P.M. - To consider a request for an Area/Bulk Variance to allow the division of 4.92 acres creating one 3 acre +/- tract with 50 ft. of frontage instead of the 100 ft. required and one 2 acre +/- tract instead of the 3 acres required in an "RR-3" Rural Residential Zone District on property known as 1355 Scott Troy Road, Lebanon, IL
